Update of the Long Range Transportation Plan

Adams informed the Policy Board the approved plan is due March 27, 2016. Mid-January the draft of the Long Range Transportation Plan will be complete. The travel demand model has been completed with forecast for 2025 & 2040.

Legislative Update of the Federal Transportation Bill

Adams provided an update that the Transportation Bill was passed by the Senate this past summer and was just extended another 2 weeks on November 20, 2015. The current extension is set to expire on December 4, 2015.
