THIS AGREEMENT made and entered into, by and between

pereinafter called the Contractor, and the City of Grand Island, Nebraska, hereinafter called the City.
VITNESSETH:
THAT, WHEREAS, in accordance with law, the City has caused contract documents to be prepared and advertisement calling for bids to be published, for construction of
TREE TRIMMING CONTRACT 2018-TT-1 SECTIONS - ; and
NHEREAS, the City, in the manner prescribed by law, has publicly opened, examined, and canvassed the bisubmitted, and has determined the aforesaid Contractor to be the lowest responsive bidder, and has diswarded to the said Contractor a contract therefore, for the sum or sums named in the Contractor's bid, a contract being attached to and made a part of this contract;
NOW, THEREFORE, in consideration of the compensation to be paid to the Contractor and of the mutuagreements herein contained, the parties have agreed and hereby agree, the City for itself and its successored the Contractor for itself, himself, or themselves, and its, his, or their successors, as follows:
ARTICLE I. That the Contractor shall (a) furnish all tools, equipment, superintendence, transportation, and off construction materials, services and facilities; (b) furnish, as agent for the City, all materials, supplies a equipment specified and required to be incorporated in and form a permanent part of the completed work; provide and perform all necessary labor; and (d) in a good substantial and workmanlike manner and accordance with the requirements, stipulations, provisions, and conditions of the contract documents as listed the attached General Specifications, said documents forming the contract and being as fully a part thereof at repeated verbatim herein, perform, execute, construct and complete all work included in and covered by the City of the contract of this contract to the said Contractor, such award being based on the acceptance by the City of the contractor's bid;
ARTICLE II. That the City shall pay to the Contractor for the performance of the tree trimming embraced in t Contract and the Contractor will accept as full compensation therefore the sum (subject to adjustment as provided by the Contract) of
Covered by and included in the Contract award and designated in the foregoing Article I; payments thereof to made in cash or its equivalent in the manner provided in the General Specifications.
ARTICLE III. It is understood and agreed that time is the essence of the Contract. No work shall commence use the Certificate of Insurance and bonds are approved by the City and the Contract is executed. The proposed will commence as soon as possible after Contract execution, and that the Contractor shall complete the world or before May 31, 2017 for Tree Trimming Contract 2018-TT-1.
ARTICLE IV. The Contractor agrees to comply with all applicable State fair labor standards in the execution

this contract as required by Section 73-102, R.R.S. 1943. The Contractor further agrees to comply with the provisions of Section 48-657, R.R.S. 1943, pertaining to contributions to the Unemployment Compensation Fund of the State of Nebraska. During the performance of this contract, the contractor and all subcontractors agree not to discriminate in hiring or any other employment practice on the basis of race, color, religion, sex, national origin,

age or disability. The Contractor agrees to comply with all applicable local, State and Federal rules and regulations. The Contractor agrees to maintain a drug-free workplace and to provide a copy of its policy to the City upon request.
