1. Parts will be supplied by a factory authorized supplier.
2. The factory authorized supplier shall be authorized to provide services to this region.
3. Installation and Startup of equipment will be by a factory authorized technician and will include time to install, program and trouble shoot equipment. Installation and Startup time shall not include travel costs.
4. Controller shall have Digital Outputs for at least Pump On, Alarm and Remote
5. Controller shall have Digital Inputs for at least Run signal.
6. Controller shall have Analog Inputs for at least Pump Speed Reference.
7. Controller shall have Analog Outputs for at least Pump Speed Reference.
8. Controller shall be able to adjust polymer dosage while in operation.
9. Parts bid as an equal to listed part numbers will be considered.
