Bids will be publicly opened at this time in Conference Room #1 located on 1st floor of City Hall. Bids received after the specified time will be returned unopened to sender.

Bids shall be submitted on forms which will be furnished by the City OR bidding documents, plans, and specifications for use in preparing bids may be downloaded from the Quest CDN website, www.QuestCDN.com for a thirty dollar (\$30) fee. Bids must be uploaded to the Quest CDN website and received before the specified time to be considered. Each bidder shall submit with their bid a certified check, a cashiers check or bid bond payable to the City of Grand Island Treasurer in an amount no less than five percent (5%) of the bid price which shall guarantee good faith on the part of the bidder and the entering into a contract within twenty (20) days, at the bid price, after acceptance by the City. ONE (1) 2022 SOLID WASTE TRANSFER TRAILER

The unit described shall be new, 2022 Model Solid Waste Transfer Trailer, that is the manufacturer's latest design and production, complete, serviced, ready for work, including all standard equipment and any optional equipment as deemed necessary by the City of Grand Island. The City will consider any unit that meets or exceeds required minimum specifications as stated herein or any approved equal unit. The City of Grand Island reserves the right to reject any or all bids and waive any technicalities.

APPLICATION: This semi-trailer will be used in the City's solid waste disposal operations. The unit will operate on paved streets and highways as well as unimproved roads and off-road applications at landfill sites. The semi-truck and trailer combination shall be configured to carry the maximum payload permitted under law (90,000 GVCW).

The unit shall be compatible with top-loading applications. Unit shall be capable of continuous loading/unloading of mixed municipal solid wastes without damaging sidewalls, door, or top rails.

CODE COMPLIANCE: The units shall comply with all Federal and State of Nebraska standards for highway use semi-trailers, which are in effect on the date of delivery.

The unit shall have capacity and identification plates with a statement that the truck-tractor complies with all applicable Federal and State laws and regulations relating to motor vehicle operations, safety, noise abatement and emission control.

The City of Grand Island reserves the right to accept or reject trade-in offers.

REQUIRED MINIMUM SPECIFICATIONS

TRANSFER TRAILER: The units shall be equipped as follows:

1. MODEL:

A 2022 model solid waste transfer trailer; shall not be built-up from a lighter unit to comply with these specifications.

2. **DIMENSIONS:**

- A. Overall length: 48 feet minimum.
- B. Overall width: 102 inches maximum with approximate 4" taper to nose.
- C. Overall height: 13'-6" maximum.
- D. Interior height: 106" minimum.
- E. Capacity: 125 cubic yard minimum.

3. CONSTRUCTION:

A. Sides: High-yield minimum 12 ga. steel, 50,000# minimum yield strength corrugated sheet post design, 2" corrugations on 12" centers, continuous weld. Bidder shall submit detail of sidewall construction.

B. Bottom rail: 7 gauge 50,000# minimum yield formed channel. Top rail: Minimum 3" x 5" x 5/16" heavy wall high strength tube. 50,000# minimum yield strength.

- C. Cross sills: 4" deep (minimum), I-beam, on 12" centers. 80,000# minimum yield strength.
- D. All welds shall be continuous, not skip welded.
- E. Under structure: King pin section and cross sills must be welded to bottom rail.
- F. King pin cross sills: Heavy-duty I-beam fabricated from 100,000# psi, 4" deep x 6" wide x ½" material.
- G. Cat Walk: Across front of trailer extending approximately 12" out, minimum 46" below top rail with ladder to bottom of trailer on driver's side.
- H. Joints: Front corners, rear header and middle cross bar to be flexible, bolt-in and mounted flush with top rail. A cross bar at the trailing edge of front end cap and crossbars at leading and trailing edge of rear cap. Must be the same as middle cross bar (bolt-in and mounted flush at top rail). End caps to be flat steel, minimum of 18" wide and 3/16" 1/4" thick.

4. CHASSIS (SUB-FRAME):

A. Dual axle mounted on steel sub-frame; 8" x 4" x ¼" rectangular tube approximately 118" long at 19.02 pounds per foot, fully welded to longitudinal; two heavy duty tow hooks attached to steel tube push block.

5. SUSPENSION:

- A. Hutch 9700, 50,000# rated suspension, or equivalent.
- B. Axles: Dual (2) Rockwell TQ4671 Q-Plus, 25,000# capacity or equivalent. 5" round, 77-1/2" track, Rockwell auto slack adjusters, or equivalent.
- C. Landing gear: Mark V Holland with square cushioned skid foot, driver's side crank, or equivalent, securely mounted and braced.
- D. Fifth Wheel: Heavy-duty 3/8" steel plate with two inch SAE pin setting at thirty-six inches.

6. BRAKES:

A. Air operated Q-Plus brakes or equivalent. 16-1/2" x 7" standard S-cam type on all axles. Equipped with non-asbestos lining.

7. TIRES AND WHEELS:

- A. Tires: Goodyear Uni-Steel G751 11 R x 24.5 tubeless, radial, load range H, or equivalent.
- B. Hubs: 10-stud outboard mount brake drum.

C. Wheels: 8.25 x 24.5 10-hole hub pilot steel disk wheels.

8. REAR DOOR:

- A. Door shall be a single door design, full door. Door will swing to the curbside of the trailer. There shall be a minimum of five (5) hinges on the door. All hinges shall be ³/₄" x 4" cold rolled C1018 steel. The door hinge pins shall be 1" stainless steel with bronze bushing. Door hinges shall have grease fittings.
- B. Locks and latches shall be designed so that they do not project out to the side of the trailer when the doors are opened. The door shall latch shut with a minimum of a four-hook system. Door locks shall have grease fittings.
- C. Door sheets shall be minimum 12 gauge material. Door frames shall be approximately 3" x 3" x 3/16" square tubing. Door shall be able to be locked into the open position with a heavy-duty retainer. Door shall be equipped with a closed-door rest on the latch side to prevent sagging.

9. LIGHTS AND REFLECTORS:

A. I.C.C. approved, rubber mounted, 12 volt L.E.D. to include stop and tail lights mounted on rear door, mid-trailer side turn indicator, marker and I.D. lights, and complete wiring harness to be sealed and protected.

10. PAINTING (STATE STANDARD COLORS AVAILABLE):

- A. Surface preparation: All surfaces to be painted shall be cleaned of all mill scale, rust, spatter slag, or flux deposits, oil, grease, dirt, or other foreign matter.
- B. Paint Application: The paint shall be applied in dry, dust-free conditions and in temperature above 65 degrees F. All edges, corners, crevices, and joints shall receive special attention for thorough cleaning and adequate paint thickness.
- C. Prime Coat: All metal surfaces, interior and exterior, shall be clean and dry. Metal surfaces shall have one coat of high quality epoxy primer applied to obtain a minimum thickness of 1 mil. per coat.
- D. Under structure: Cross members and 1 x 1 tubing shall be primed before the flooring is installed.
- E. Finish coats: All exterior surfaces of the trailer shall have two (2) coats of polyurethane enamel, applied in accordance with the manufacturer's recommendations and shall have a minimum dry film thickness of 1 mil. per coat.

11. WALKING FLOOR:

KEITH hydraulic operated, two-way system center frame drive, 35-ton capacity, Keith Running Floor II DX11 with 2 year warranty, with no hydraulic hoses.

- A. The walking floor unloader is to have actuated #2301 High Impact aluminum floor extrusions. Each extrusion must have a slot to accommodate #1212 floor seal.
- B. Each floor extrusion must be secured to the drive mechanism with (6) min. 5/16" x 1" Allen type counter sunk bolts, grade 8 with self locking nuts.
- C. The hydraulic cylinder shafts must be attached to the frame with (8) 5/8" bolts, and will remain stationary. The 2" x 6" cross drives are to be clamped directly to the hydraulic cylinder and must be removable, independently, for service.
- D. The floor extrusions must be supported at each end and cross member by 24 high-density #3003 and 3004 plastic bearings where #2228 splash guard bearing is not present. Each of these must have 30.21 (minimum) square inches on top between floor extrusion and bearing mount. 5.03 square inches at each side of lower portion, providing bearing surface between the lower foot of the front extrusion and the cross member shall be 2.0 (min.) inches in length. Splash guard #2228 will be placed over and extending 3 feet in front of trailer axles and 12 feet back from front of trailer.
- E. Hydraulic system shall be powered by PTO driven hydraulic pump, mounted on the tractor transmission. Pump rating to be 30 GPM at 3,000 psi. Hydraulic components shall meet requirements of manufacturing of walking floor.

A. No cover/tarping system is requested with this transfer trailer.
