The City of Grand Island Streets Division requests quotes for the Mowing and Landscape Area Maintenance 2021. Vendor is to supply all personnel, material and equipment for this work according to the specifications.

All written quotations will be **received at the office of the City Clerk**, 100 E. First Street., Grand Island, NE 68801 or P.O. Box 1968, Grand Island, Nebraska 68802 until **2:15 p.m., (Local Time), Thursday, March 10, 2022** for the **Mowing and Landscape Area Maintenance 2022** for the City of Grand Island. Quotes will be publicly opened at this time in the Conference Room #1 located on 1st floor of City Hall. Quotes received after specified time will be returned unopened to sender.

Quotes shall be submitted on forms which will be furnished by the City OR quote documents, plans, and specifications for use in preparing quotes may be downloaded from the Quest CDN website, www.QuestCDN.com for a thirty dollar (\$30) fee. Quotes must be uploaded to the Quest CDN website and received before the specified time to be considered.

Please return one original and one copy of each quote sheet.

The successful vendor will be required to comply with fair labor standards as required by Nebraska R.R.S. 73-102 and comply with Nebraska R.R.S. 48-657 pertaining to contributions to the Unemployment Compensation Fund of the State of Nebraska.

Successful vendor shall comply with the City's insurance requirements and shall maintain a Drug Free Workplace Policy.

Quotes will be evaluated by the Purchaser based on price, quality, adherence to schedule, plan and specification, economy and efficiency of operation, experience and reputation of vendor, ability, capacity, and skill of the vendor to perform contract required and adaptability of the particular items to the specific use intended.

The Purchaser reserves the right to reject any or all quotes and to waive irregularities therein and to accept whichever quote that may be in the best interest of the City, at its sole discretion.

General Specifications for Mowing and Landscaping Area Maintenance 2022

The City of Grand Island Streets Division is soliciting quotations for mowing and landscape area maintenance for 27 locations; each area will be considered a separate job and awarded individually.

Maps with notes about each location are attached.

SCOPE:

Work and frequency for each area will vary and is detailed on the individual area bid sheet. The Contractor providing these services shall include furnishing all labor, equipment, tools, insurance, supervision, and materials along with all other items incidental thereto and to perform all work necessary to complete the work as specified, and in the prescribed manner and time.

Specific instructions/work limits are noted for each individual area.

MOWING/TRIMMING:

Mowing grass or vegetation shall be completed with conventional mowing equipment. Use specialized equipment or hand labor when required to complete the job in certain areas. Trimming shall include trimming around all trees, signs, fire hydrants, utility markers and cabinets, signal cabinets, utility poles & guy wires, etc. Area to be mowed and trimmed are shown on map for each location.

Any streets or sidewalks adjacent to work area(s) shall be free and clear of grass clippings/removed vegetation before leaving the work site.

SEASON:

The season shall run from April until the end of October; specific dates will be determined based on weather and rain. A notice to proceed shall be given prior to any mowing or landscape maintenance work being conducted. If additional work is required at the end of the season, an extension shall be requested and approved by the Streets Division prior to additional work taking place.

INTERVAL:

Interval stated on bid form(s) will be the highest frequency required at peak growing season. Early/late growing season may be reduced as directed by the Street Superintendent, or designated representative.

BID PRICE:

Each area will be considered a separate job and awarded individually based on Contractor's pricing for each area. Contractors may submit pricing for any, all, or no sections of this request and the City may select any, all, or no sections in this request to be awarded.

For bidding purposes, the following should be used as the number of mowing/trimming each season in order to calculate total bid price:

Once per Season = 1 x \$ per each

Twice per Month = 14 x \$ per each

Once per Week = 28 x \$ per each

Quantities on bid form are approximate and Contractors are encouraged to visit the site prior to bidding. Unit prices shall be for each mowing and shall be honored until December 31, 2021.

INVOICING & PAYMENT:

Invoicing for services provided shall be sent to the Streets Division a minimum of once per month. The invoice shall state the location and date of the service provided.

PUBLIC CONVENIENCE AND SAFETY:

The Contractor shall observe City ordinances relating to obstructing streets, keeping passageways open and protecting same, and shall obey all laws and City ordinances controlling or limiting those engaged in the work. The Contractor is granted the privilege of using the street or streets for the purpose of doing work specified in the Contract, but he is not granted exclusive use of such street or streets. The Contractor shall handle the work in a manner that will cause the least inconvenience or nuisance to the general public and to property.

INSPECTION:

The City of Grand Island Street Superintendent or designated representative will inspect the work of the contractor. The Street Superintendent or designated representative may suspend operation, if in their opinion it is not being performed in a safe manner, or not in accordance with the contract specifications. The acceptance of an individual unit of work is solely within the discretion of the Street Superintendent or designated representatives.

OTHER REQUIREMENTS: Compliance with the Nebraska Fair Labor Standards, the City's Insurance Policy and the City's Drug Free Work Place Policy will be required. If copies of these policies are needed, please contact the Streets Division at 308-385-5322.

1. 2nd & Greenwich Curve



Location Description: 2nd St and Greenwich St

Acres (approximate): 0.05

Notes: Areas to be mowed are highlighted.

Interval: Mowing/Trimming - Twice per Month

2. 2nd St Overpass



Location Description: Hwy 30 between Old Hwy 30 (east) and Garfield Ave; NE, NW, and SE quadrants & Blaine St under the viaduct.

Acres (approximate): 1.18

Notes: Areas to be mowed are highlighted and include 15' on either side of Blaine St under the viaduct. Mowing/trimming on the north side of viaduct is only required from the curb to 5' from back of sidewalk. Mowing/Trimming on the south side of viaduct will include the entire grassed area (including along cable rail and slope) as highlighted. Grass clippings shall be removed from the sidewalk before leaving the work area.

Interval: Mowing/Trimming - Twice per Month

3. 13th St between North Rd and Moore's Creek



Location Description: 13th Street between North Rd and Moore's Creek (east of Cedar Ridge Ct) and 13th/North Rd Radii.

Acres (approximate): 2.3

Notes: Areas to be mowed are highlighted.

Mowing width of approximately 20' from back of curb. Grass clippings shall be removed from the sidewalk before leaving the work area. Weeds/Grass around and between utility poles (south side of road) shall be mowed or trimmed each time.

Turf edging of sidewalks and back of curb shall be mechanically edged to a 1" depth and ¼" width. Dislodged material caused by edging shall be removed from the site.

Interval: Mowing/Trimming - Twice per Month; Turf Edging – Once per Season

4. 1420 Stolley Park Rd



Location Description: Storm water detention pond frontage north of Stolley Park Rd west of Adams St.

Acres (approximate): 0.15

Notes: Areas to be mowed are highlighted.

Stolley Park Rd right-of-way shall be mowed and trimmed from curb to approximately 30' from back-of-curb. Grass clippings shall be removed from the sidewalk before leaving the work area.

Turf edging of sidewalks shall be mechanically edged to a 1" depth and ¼" width. Dislodged material caused by edging shall be removed from the site.

Interval: Mowing/Trimming - Twice per Month; Turf Edging – Once per Season

5. 3360 W Capital Ave



Location Description: Storm water detention pond frontage north of Capital Ave between Plaza Dr and Webb Rd.

Acres (approximate): 0.15

Notes: Areas to be mowed are highlighted.

Capital Ave right-of-way shall be mowed and trimmed from curb to approximately 35' from back-of-curb. Grass clippings shall be removed from the sidewalk before leaving the work area.

Turf edging of sidewalks and back of curb shall be mechanically edged to a 1" depth and ¼" width. Dislodged material caused by edging shall be removed from the site.

Interval: Mowing/Trimming - Twice per Month; Turf Edging – Once per Season

6. Capital Ave between Wheeler Ave and Oak St



Location Description: Capital Ave (south side) between Wheeler Ave and Oak

Acres (approximate): 0.99

Notes: Areas to be mowed are highlighted.

Mowing/trimming width shall be from edge of pavement (or back of curb) to approximately 5' from back of sidewalk. Grass clippings shall be removed from the sidewalk before leaving the work area.

Interval: Mowing/Trimming - Twice per Month

7. Diers Ave between State St and 13th St



Location Description: Diers Ave Right-of-Way (east side) between 1716 Diers Ave and 1309 Diers Ave.

Acres (approximate): 0.32

Notes: Areas to be mowed are highlighted. Diers Ave right-of-way shall be mowed/trimmed from curb to approximately 10' from back of curb. Grass clippings shall be removed from the sidewalk before leaving the work area.

Interval: Mowing/Trimming - Twice per Month

8. Diers Ave between 13th St and Concord Ave



Location Description: Diers Ave Right-of-Way (east side) between 819 Diers Ave and 1227 Diers Ave.

Acres (approximate): 0.18

Notes: Areas to be mowed are highlighted. Diers Ave right-of-way shall be mowed/trimmed from curb to approximately 10' from back of curb. Grass clippings shall be removed from the sidewalk before leaving the work area.

Interval: Mowing/Trimming - Twice per Month

9. Diers Ave between Arlington Cir and Old Potash



Location Description: Diers Ave Right-of-Way (east side) between 111 Diers Ave and 425 Diers Ave.

Acres (approximate): 0.18

Notes: Areas to be mowed are highlighted. Diers Ave right-of-way shall be mowed/trimmed from curb to approximately 10' from back of curb. Grass clippings shall be removed from the sidewalk before leaving the work area.

Interval: Mowing/Trimming - Twice per Month

10. East Down Town Entrance



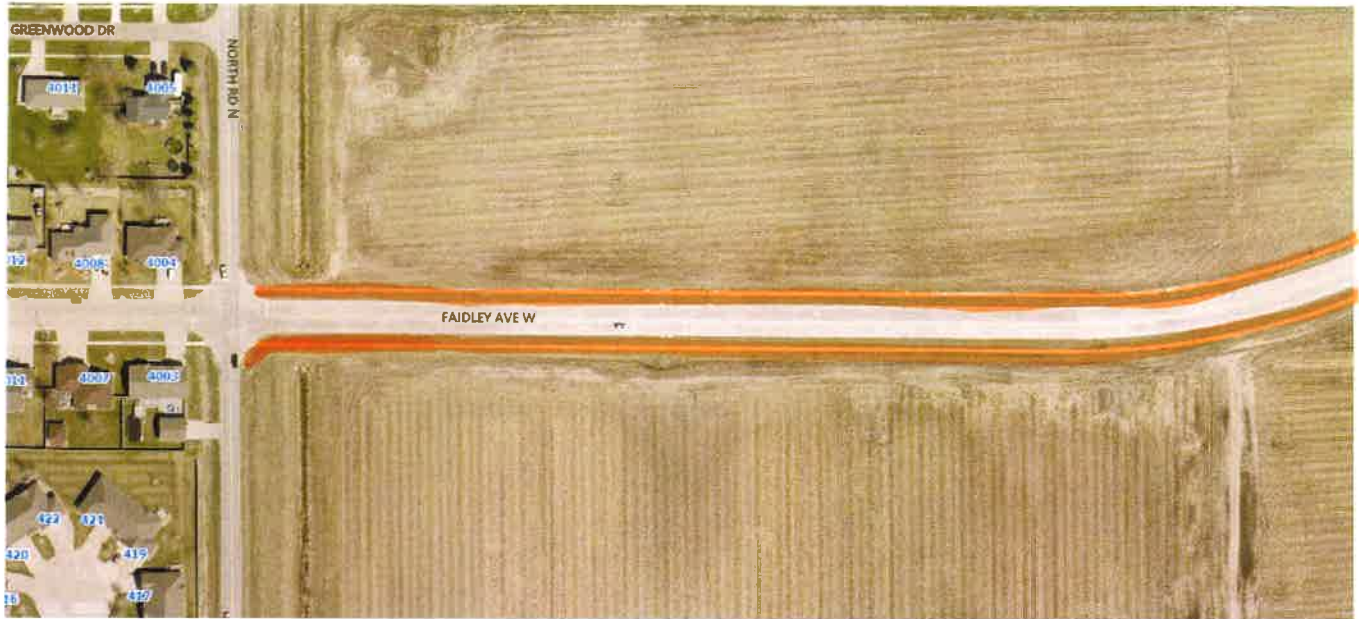
Location Description: Hwy 30 between Plum St and Public Safety Dr.

Acres (approximate): 0.95

Notes: Areas to be mowed are highlighted; includes sidewalk area on the south side of Hwy 30 and the area between Plum St and UPRR Dr on the north side. Mowing/Trimming width shall be approximately 12' from back of curb. Grass clippings shall be removed from the sidewalk before leaving the work area.

Interval: Mowing/Trimming - Twice per Month

10. Faidley – North Rd to Claude Rd & Irongate Ave



Location Description: Faidley Ave between North Rd and Claude Rd & Iron Gate Ave.

Acres (approximate): 1.8

Notes: Areas to be mowed are highlighted. Faidley Ave right-of-way extends approximately 20' from back of curb. On Irongate Ave, mowing/trimming width will be back of curb to chainlink fence (both sides) for approx. 90' north of Faidley. Grass clippings shall be removed from the sidewalk before leaving the work area. Turf Edging of sidewalks and back of curb shall be mechanically edged to a 1" depth and ¼" width. Dislodged material caused by edging shall be removed from the site.

Interval: Mowing/Trimming - Twice per Month

12. Fonner Park Rd & Pleasant View Dr and Fonner Park Rd & Stuhr Rd



Location Description: Right-of-Way (ROW) frontage on east side of Pleasant View Dr at Fonner Park Rd and west side of Stuhr Rd at Fonner Park Rd.

Acres (approximate): 0.2

Notes: Areas to be mowed are highlighted.

Pleasant View Dr right-of-way shall be mowed and trimmed to approximately 70' from back of curb; to include mowing and trimming around retaining wall of culvert pipe.

Stuhr Rd right-of-way shall be mowed/trimmed to approximately 25' from edge of pavement ; trimming to include back of fence and around culvert retaining wall.

Grass clippings shall be removed from the sidewalk before leaving the work area.

Interval: Mowing/Trimming - Twice per Month

13. Hwy 30 – Webb Rd to Old Hwy 30



Location Description: Hwy 30 Frontage between Webb Rd & Old Hwy 30 and portion of Old Potash & Old Hwy 30 Frontage.

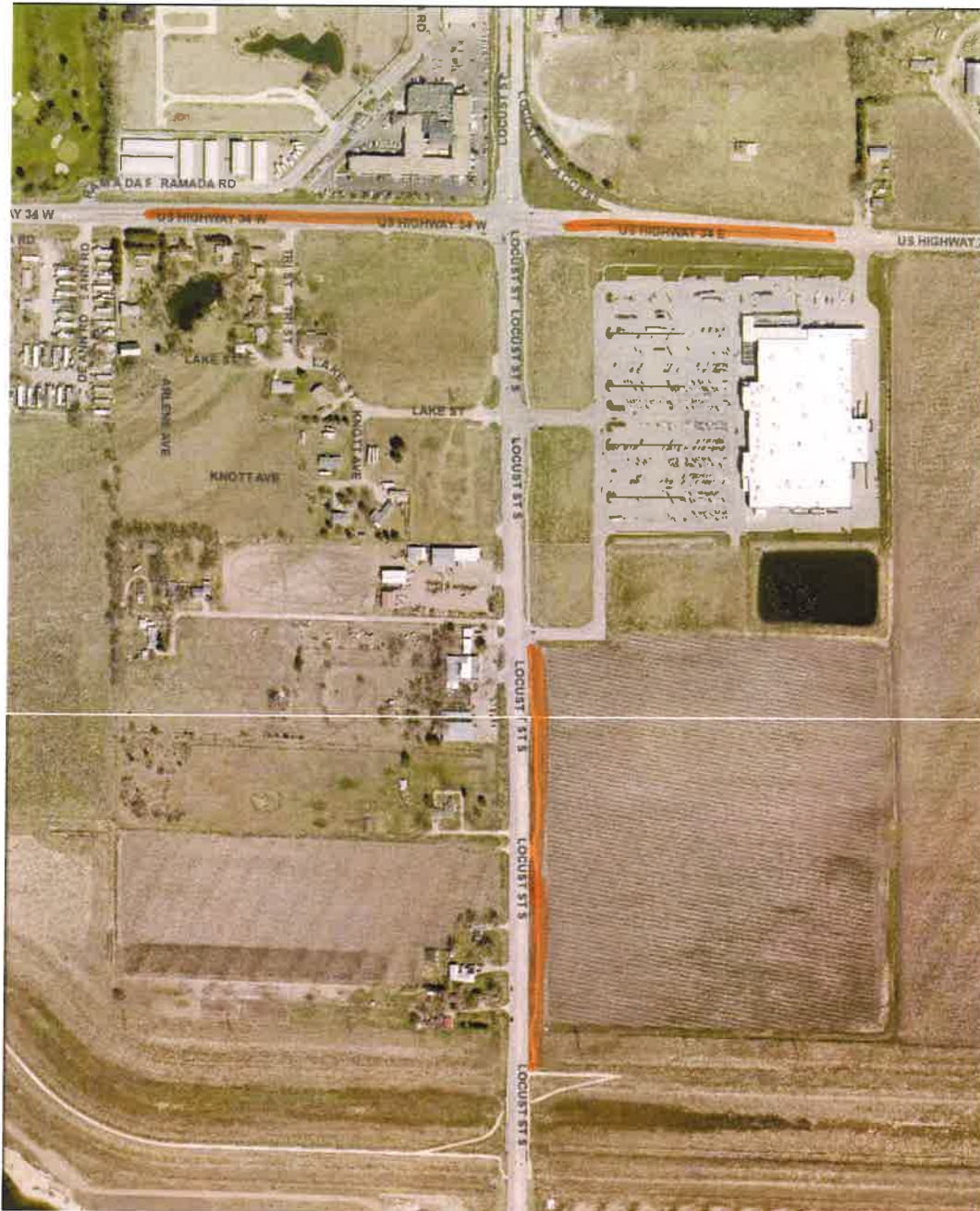
Acres (approximate): 1.06

Notes: Areas to be mowed are highlighted. Mowing/Trimming shall be done around the perimeter of areas from back of curb (or edge of pavement) for a width of approximately 6'.

Some business owners mow this section in front of business; mowing, only mow areas in need and price reduction can be discussed at that time.

Interval: Mowing/Trimming - Twice per Month

14. Hwy 34 and South Locust



Location Description: Hwy 34 and South Locust & South Locust between Walmart Drive and Bridge

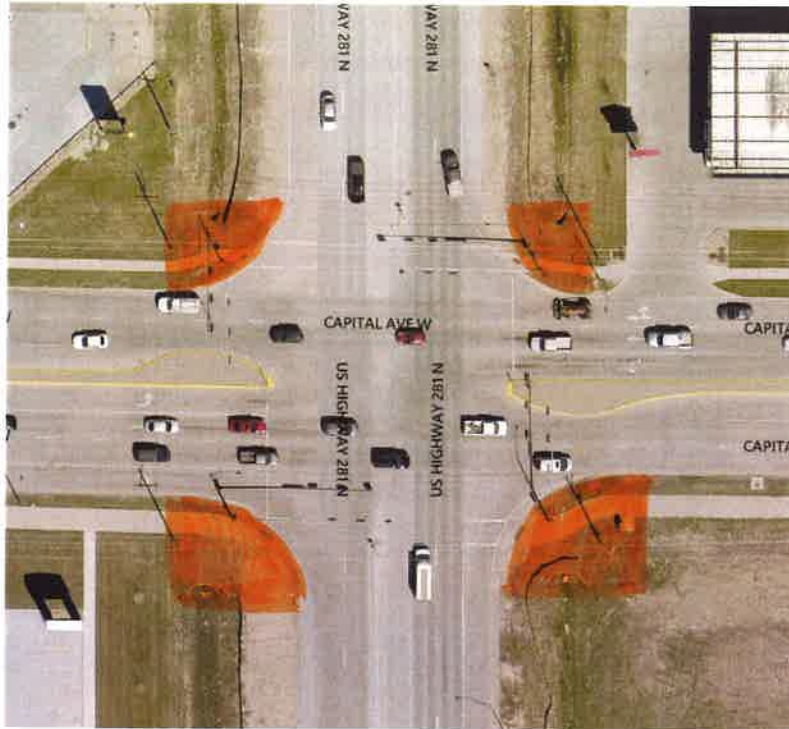
Acres (approximate): Grass Medians – 0.66; Bike Trail and ROW south of Walmart – 1.26

Notes: Areas to be mowed are highlighted. Grass in Hwy 34 medians and South Locust right-of-way between Walmart's south driveway and the bike trail bridge. South Locust right-of-way to include area between roadway and bike trail and approximately 5' on the east side of bike trail. Grass clippings shall be removed from the sidewalk/bike trail before leaving the work area.

Interval: Mowing/Trimming - Twice per Month

15. Hwy 281 Intersections – Capital Ave to Faidley Ave

Hwy 281 and Capital Ave



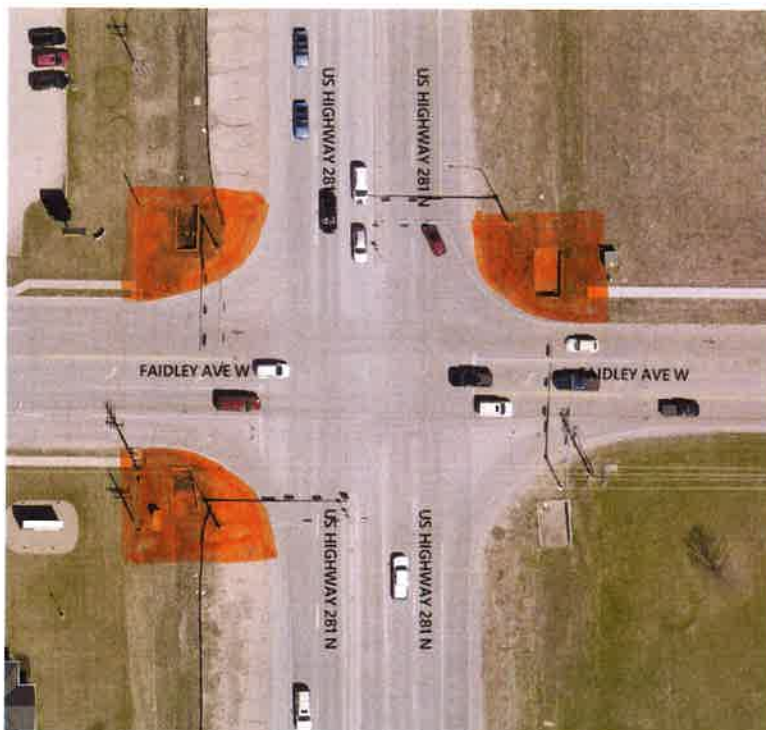
Hwy 281 and State St

Location Description: Hwy 281 Right-of-Way at various locations and intersections between Capital Ave and Faidley Ave

Acres (approximate): Hwy 281 & Capital (0.16 acres); Hwy 281 & State (0.16 acres); Hwy 281 & 13th (0.26 acres); Hwy 281 & Faidley (0.11 acres).

Notes: Areas to be mowed are highlighted. In general, area to be mowed/trimmed are the radii: around culvert opening or walls, signal cabinets, utility poles & guy wires, light poles, and utility marks/cabinets. Contractor will not be required to mow/trim the bottom of ditch on these corners.

Grass clippings shall be removed from the sidewalk before leaving the work area.

Interval: Mowing/Trimming - Twice per Month

16. Oak St – North Front St & South Front St



Location Description: Oak St at North Front St & Oak St at South Front St

Acres (approximate): 0.37

Notes: Areas to be mowed are highlighted. West side of Oak St, north of RR Tracks and south of North Front St., between roadway and sidewalk right-of-way which extends approximately 15' from back of curb. Grass clippings shall be removed from the sidewalk before leaving the work area.

Interval: Mowing/Trimming - Twice per Month

17. Plum St & Sutherland St



Location Description: Sutherland St between Plum St and Bike Trail, south side.

Acres (approximate): 0.37

Notes: Areas to be mowed are highlighted.

Interval: Mowing/Trimming - Twice per Month

18. Streets Shop



Location Description: 1111 W North Front St. & 346 Lincoln Ave.

Acres (approximate): 0.12

Notes: Areas to be mowed are highlighted.

Bagging of grass clippings/cut vegetation is required and Contractor shall be responsible for disposal. Street and sidewalk areas shall be clear of vegetation prior to leaving work area.

Interval: Mowing/Trimming – Once per Week

19. Streets West Yard



Location Description: 2124 Old Lincoln Hwy & 2123 George St

Acres (approximate): 0.12

Notes: Areas to be mowed are highlighted; Frontage along Old Lincoln Hwy and frontage along George St. Bagging of grass clippings/cut vegetation is required and Contractor shall be responsible for disposal. Street and sidewalk areas shall be clear of vegetation prior to leaving work area.

Interval: Mowing/Trimming – Once per Week

20. 4325 Kay Ave



Location Description: Storm water detention pond on Kay Ave; west of Viking Rd on south side of Kay Ave.

Acres (approximate): 0.9

Notes: Areas to be mowed/trimmed are highlighted.

Grass clippings shall be removed from the sidewalk and street before leaving the work area.

Interval: Mowing/Trimming - Twice per Month

21. 2415 E. Hwy 30



Location Description: Storm water detention pond frontage on south side of Hwy 30; both sides of Seedling Mile Access Rd.

Acres (approximate): 0.16

Notes: Areas to be mowed/trimmed are highlighted.

Hwy 30 right-of-way shall be mowed and trimmed from curb to approximately 20' from back-of-curb and radii at intersection of Seedling Mile Access Rd including around sign post(s). Grass clippings shall be removed from the street & sidewalk before leaving the work area.

Grass clippings shall be removed from the sidewalk and street before leaving the work area.

Interval: Mowing/Trimming - Twice per Month

22. North Rd – Hwy 2 to Capital Ave



Location Description: North Rd between Hwy 2 and Capital Ave

Acres (approximate): 0.48

Notes: This stretch of North Rd is now curb & gutter section and vendors are encourage to drive the site before placing bid. Areas to be mowed are highlighted; majority is ROW along agricultural properties or City-owned properties. North Rd mowing shall extend approximately 8' from back of curb (utility pole line). Weeds/Grass around and between utility poles shall be mowed or trimmed each time.

Grass clippings shall be removed from the street and/or sidewalk before leaving the work area.

Interval: Mowing/Trimming - Twice per Month

23. State St & North Rd



Location Description: State St between Meadow Rd and North Rd (south side) & North Rd between State St and Bike Trail crossing (east side).

Acres (approximate): 0.55

Notes: This area is now curb & gutter section with a round-a-bout at State St & North Rd. Vendors are encourage to drive the site prior to bidding. New seeding on large portion of this area therefore entire are may not need mowed for the whole season.

Areas to be mowed are highlighted. Mowing width of approximately 30' from back of curb and mowing/trimming to be done around box culvert walls. Grass clippings shall be removed from the street or sidewalk before leaving the work area. Weeds/Grass around the box culvert on SW corner of State/Meadow shall be mowed/trimmed each time.

Interval: Mowing/Trimming - Twice per Month

24. Claude Rd – Faidley Ave between Old Potash Hwy



Location Description: Claude Rd between Faidley Ave and Old Potash Hwy

Acres (approximate): 0.85

Notes: This stretch of Claude Rd is curb & gutter section and vendors are encourage to drive the site before placing bid.

Areas to be mowed are highlighted; ROW along agricultural properties or City-owned properties. Claude Rd mowing shall extend approximately 2' from back of sidewalk; includes SW radius at Claude Rd & Faidley and NW radius at Claude Rd & Old Potash. Mowing/trimming shall also include street frontage around storm pond at Kaufman Ave and Claude Rd for a width of approx. 10' from back of curb.

Grass clippings shall be removed from the street and/or sidewalk before leaving the work area.

Interval: Mowing/Trimming - Twice per Month

25. Old Potash Hwy – North Rd to Old Potash Hwy



Location Description: Old Potash Hwy between North Rd and Old Potash Hwy

Acres (approximate): 0.88

Notes: This stretch of Old Potash Hwy is now a curb & gutter section and vendors are encourage to drive the site before placing bid. Areas to be mowed are highlighted; ROW along agricultural properties or City-owned properties. Old Potash Hwy mowing shall extend approximately 2' from back of sidewalk. This section includes all radii around the round-a-bout at Old Potash and North Rd at 8' from back of curb; mowing/trimming around all utility poles, markers, and signs shall be done at the round-a-bout corners.

Grass clippings shall be removed from the street and/or sidewalk before leaving the work area.

Interval: Mowing/Trimming - Twice per Month

25. Husker Hwy – Hwy 281 to west of Prairieview

Location Description: Husker Hwy between Hwy 281 to west of Prairieview

Acres (approximate): 0.97

Notes: Areas to be mowed are highlighted. Husker Hwy mowing shall extend approximately 10' from back of curb and shall include all radii at Husker Hwy and Prairieview Round-a-bout. Mowing/trimming on the SW radius at Hwy 281 and Husker Hwy will include upto and around culvert retaining wall. This section includes the NW radius of round-a-bout at Prairieview St and Husker Hwy. Grass clippings shall be removed from the street and/or sidewalk before leaving the work area.

Interval: Mowing/Trimming - Twice per Month

26. Platte Valley Blvd – Hwy 281 to Juergen Rd

Location Description: Platte Valley Blvd between Hwy 281 and Juergen Rd (Platte Valley Industrial Park)

Acres (approximate): 0.28

Notes: Areas to be mowed are highlighted. Platte Valley Blvd grass median and right-of-way between Hwy 281 and Juergen Rd. Platte Valley Blvd right-of-way to be mowed/trimmed to approximately 10' from back of curb and around radii with intersecting streets. Grass clippings shall be removed from the sidewalk/bike trail before leaving the work area.

Interval: Mowing/Trimming - Twice per Month
