We hereby submit specifications and estimates for:

Base Bid 60 mill, Black, Fully Adhered EPDM roof system.

Remove existing EPDM roof system to the deck, wall flashing will remain under concrete coping cap. New EPDM flashing will be sealed to the existing EPDM flashing.

Loose lay 1/8" per foot tapered EPS system and mechanically attach one layer of 2.6" ISO.

Install 60 mil black EPDM fully adhered roof system and membrane flashings at all curbs and penetrations per Firestone specifications

Install EPDM 4 walk pads at each roof ladder access

Roof will carry a Firestone Red Shield 10-year Warranty with a wind speed warranty of 55 MPH

Install shop fabricated 24-gauge pre-finished metal counter flashing at roof hatch. Existing counter flashing will remain in place and be re-used at termination for the new roof system. Color from manufactures standard colors.

Metal scupper sleeves to remain, new EPDM flashing will be installed over metal sleeve

Remove and reinstall red coping cap

All wood blocking to remain.

Remove and reinstall ballast pavers on lower section around large air handler. This section will remain ballast in the field of this roof section. The walls and curb flashing will have adhered membrane, the insulations will be held down by the ballast pavers.

Front termination to be re-installed in the same manner that is currently in place. Flashed with 5" flashing to the metal wall panel.

Tuck point coping stone with NP-1 caulking. Color to best match existing stone and mortar joint color. Color chosen from standard colors.

This roof system will produce an average R value of 33. One layer of 2.6 ISO has an R value of 15 and the average R value on the tapered EPS system is 18.
