

ORDINANCE NO. 9977

An ordinance to amend the Grand Island City Code; Section 35-30, pertaining to water utility rates; to repeal Section 35-30, as now existing, and any ordinance or parts of ordinances in conflict herewith; and to provide for publication and the effective date of this ordinance.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF GRAND ISLAND, NEBRASKA:

SECTION 1. Section 35-30 of the Grand Island City Code is hereby amended to read as follows:

**§35-30. Schedule of Rates**

**Plus**

A customer charge for unfunded federal mandates for the Clean Water Act and the City's backflow program, in addition to the regular rates charged for water furnished to the customer as follows:

Effective October 1, 2024:	\$0.83 per month
Effective October 1, 2025:	\$0.89 per month

**Plus City Dividend for Utility Ownership**

All water services provided by the Grand Island Utilities Department will be subject to a City Dividend for Utility Ownership. The City Dividend for Utility Ownership will be set by resolution in the City of Grand Island Fee Schedule and calculated as a percentage of the total bill. The City Dividend for Utility Ownership will be identified as a separate line item on an electric bill and will be calculated as follows:

$$\text{City Dividend} = \text{Water Usage Bill Before Sales Tax} * (1 - (1 / (1 - \text{City Dividend})))$$

The City Dividend for Utility Ownership will be subject to applicable sales tax.


SECTION 2. Those portions of Section 35-30, as now existing, and any ordinances or parts of ordinances in conflict herewith be repealed effective 12:01 am on October 1, 2024.


SECTION 3. The validity of any section, subsection, sentence, clause or phrase of this ordinance shall not affect the validity or enforceability of any other section, subsection, sentence, clause or phrase thereof.

SECTION 4. That this ordinance shall be in force and take effect on October 1, 2024 after its passage and publication on the City's website and publication within 15 days in one issue of the Grand Island Independent as provided by law.
