The City of Grand Island is seeking proposals from qualified individuals and firms for the sale of the property at 1306 W 3rd. Street, Grand Island, NE.

The legal description of the property is:

That part of vacated Adams Street, being eighty (80) feet in width, lying between the westerly line of Block Fourteen (14) and the easterly line of Block Fifteen (15), and being two hundred eighty (280) feet in length from the northerly line of Third Street to the southerly line of South Front Street, all being in Arnold and Abbott's Addition in the City of Grand Island, Hall County, Nebraska, vacated by Ordinance No. 4999;


Submittals
