The City of Grand Island Utilities requests quotes for the non-destructive testing of its Aerial Devices and Digger Derrick units. Vendor is to supply all personnel, material and equipment for this testing and to perform testing to the attached specifications.

All written quotations received by <u>WEDNESDAY</u>, <u>JANUARY 9</u>, <u>2013</u>, will be considered. Sealed quotes, clearly marked for "Non-destructive Testing of Grand Island Utility Aerial Device and Digger Derrick Units quote", will be received at the <u>Storeroom</u>, <u>Utilities Department Service Building</u>, <u>1116 West North Front</u>, <u>Grand Island</u>, <u>NE 68801</u>. <u>Quotes will be publicly opened at the Service Building at the time stated above</u>. Any quotations received after the specified time will be returned unopened to sender. No verbal quotations accepted. All quotes must be signed and dated by your quotation department to be accepted.

Quotes will be evaluated by the purchaser based on price, quality, experience, and ability to meet purchaser's schedule. Upon completion of evaluation of quotes, the company with the successful quote will receive a purchase order and executed contract within thirty (30) days after the deadline for quotations to be in. <u>Testing must be completed by April 15, 2013.</u> Two-week notice prior to testing of vehicles will be required. NON-DESTRUCTIVE TESTING OF GRAND ISLAND UTILITY AERIAL DEVICE AND DIGGER DERRICK UNITS CITY OF GRAND ISLAND, NEBRASKA

Each Unit Must be Quoted Individually

1. STANDARDS

All testing shall be done in accordance with the following or other applicable Standards:

- a) ANSI A10.31 1987 (or latest revision) American National Standard for construction and demolition digger derricks.
- b) ANSI A92.2-1979c (or latest revision) American National Standard of Vehicle-Mounted Elevating and Rotating Aerial Devices.

For each type of test, Company is to submit a complete explanation of how they will perform such test.

QUOTE FORMAT

Company shall prepare a standard quote per each unit listed <u>(individually)</u>, for the following general classes of vehicles. Company shall specify which tests are included for each class. If any part of the required tests are not fully completed the specified unit will be deemed untested and the quoted amount will be subtracted from the total quote.

4. TIME OF TESTING

The Utilities intends to have one of its personnel witness each test. Therefore, all testing shall be performed Monday-Friday, 8:00 a.m. – 4:30 p.m. local time. Location for testing – 1116 West North Front Street, Grand Island, NE 68801. Should have two people if possible.

5. TEST REPORTING

- a) Two copies of a separate report of all test results with a clear typed explanation of any defects for each vehicle will be required. Each report will also contain recommendations for correcting such defects.
- b) For quote evaluation, a sample of copy of the Company's test report will be required.
